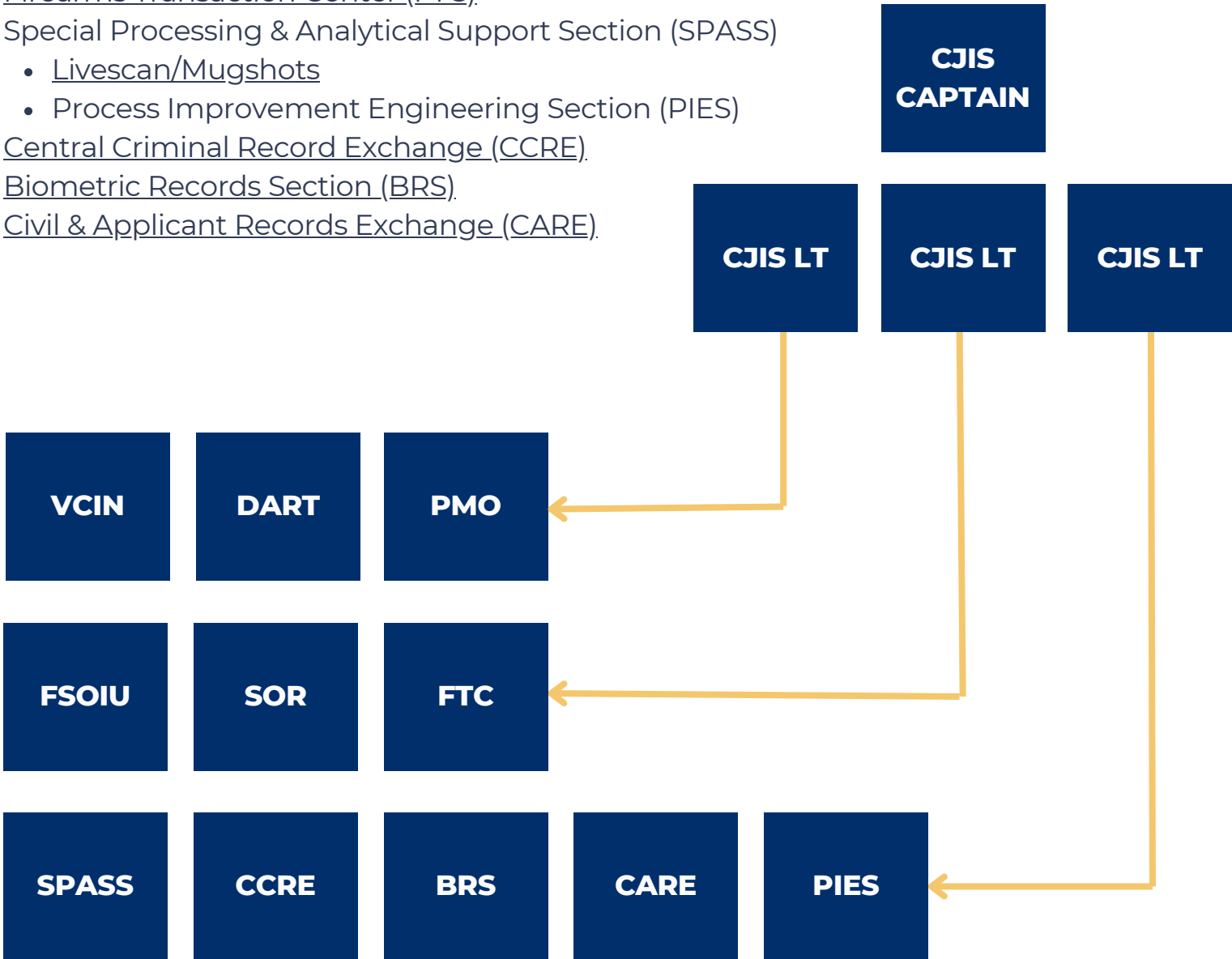

CJIS SECURITY POLICY

Under the new CJIS Security Policy version 5.9.3, effective September 14, 2023, Security Awareness Training was renamed *Security & Privacy – General* and requires users to certify annually. VCIN training will remain every two (2) years. Users will be notified when any of their certifications are set to expire. VCIN TACs can run a test activity report to keep track of their user's training if needed. Workflow charts have been created to assist agencies with their VCIN users progress and can be found on the CJIS Launch Pad site under "CJIS Documents."

JAVA CERTIFICATES UPDATE IN OPENFOX MESSENGER

On January 16, 2024, VSP will upgrade the Java Certificates that are used by the OpenFox Messenger application. The update is scheduled to be completed by noon. After 12 p.m., please ensure that each Messenger station is logged off and the application is closed completely. Relaunching the Messenger application will update and download the new Java certificates.

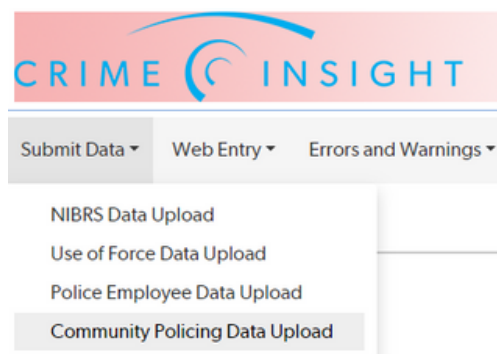

Instead, it is recommended that you type the URL directly into the web browser or make the Messenger Launch page your default web page.

COMMUNITY POLICING ACT

The DART Section continues to work on utilizing the functionality of the existing crime and use of force data repository to provide the same user friendly services for Community Policing Act (CPA) stop data. Implementation is tentatively schedule for Spring 2024.

BIPARTISAN SAFER COMMUNITIES ACT

The Bipartisan Safer Communities Act of 2022 (BSCA) now mandates that individuals below 21 years of age who wish to purchase guns undergo enhanced background checks. The checks include contacting local law enforcement and cross-checking state databases for juvenile and mental health records within three business days. This is to determine if there are any potentially disqualifying records.

According to VA Code §19.2-389.1(i), record information maintained in the Central Criminal Records Exchange (CCRE) can only be shared to verify eligibility to possess or purchase a firearm. To comply with this, the CCRE performs a thorough search of the Mental Health System (MHS) and queries the Computerized Criminal History (CCH) systems using the potential purchasers' Personal Identifying Information (PII).

The CCRE has fulfilled 281 FBI requests, 498 requests from New Jersey, and 7 from Pennsylvania. Meanwhile, the Virginia State Police Firearms Transaction Center (FTC) conducted 7,862 enhanced background checks on individuals attempting to buy firearms in Virginia.

VCHECK ENHANCEMENTS - TEXT MESSAGING

In an effort to improve and expedite the purchase of firearms, VCheck began offering a text messaging service to notify buyers who have been delayed (or are in research status) when their purchases are approved.

This optional service is being provided at no additional cost. This service requires the buyer to agree to the service and requires the buyer's cell phone number and carrier information be entered.

This functionality provides a convenience for the buyer and reduces incoming calls to the FTC.



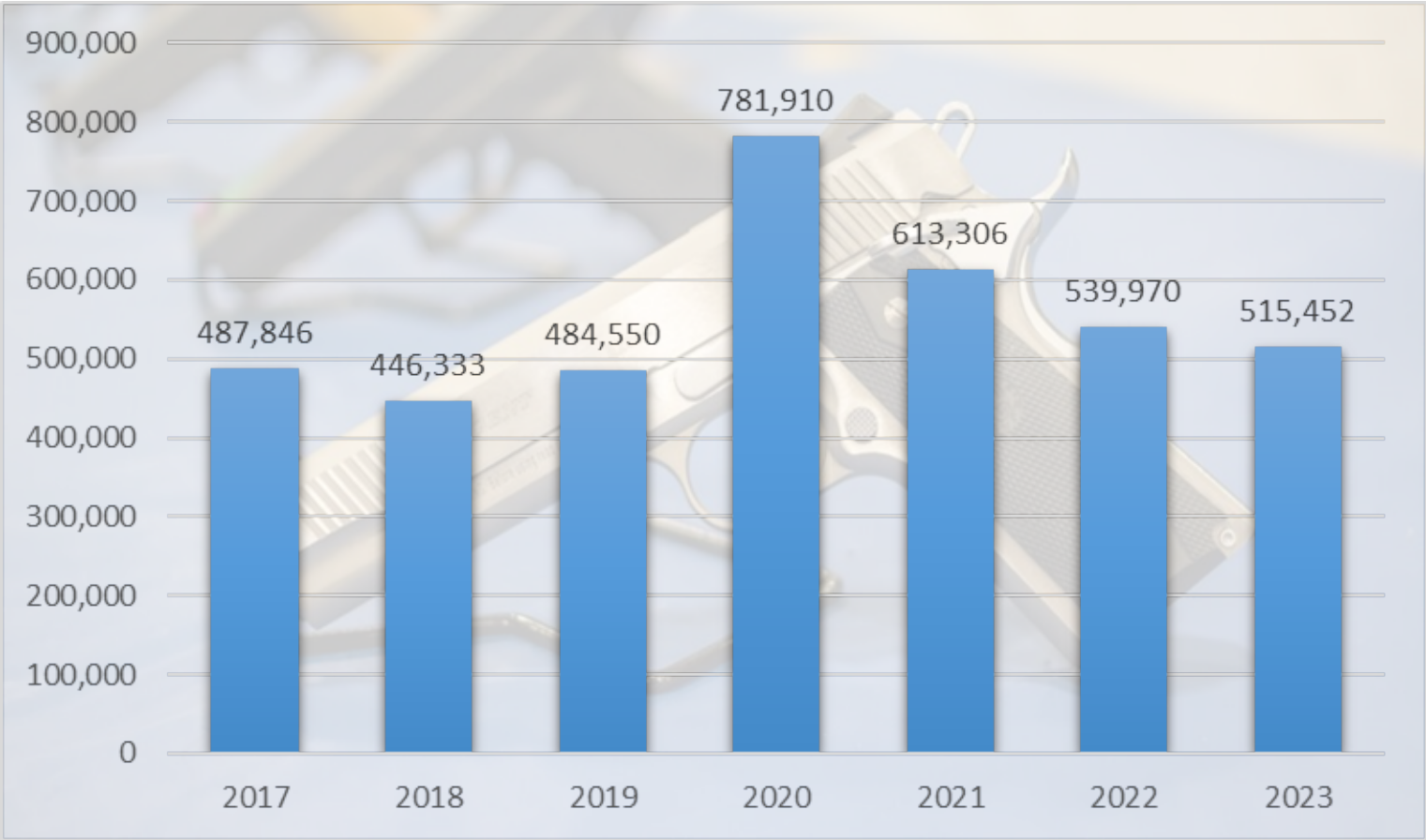
BENEFITS OF VCHECK ENHANCEMENTS

Functionality has been implemented all year to increase the effectiveness of VCheck and embrace LEAN Management principles. This functionality was implemented through several waves of roll outs, across the span of several months. Currently, VCheck uses a variety of full and partial automation to reduce the number of employee hours it takes to complete daily tasks. From auto denying transactions, to sending electronic correspondence to Sellers as a primary form of communication, the FTC has saved over 955 hours in employee work hours and reduced the amount of office supplies needed.

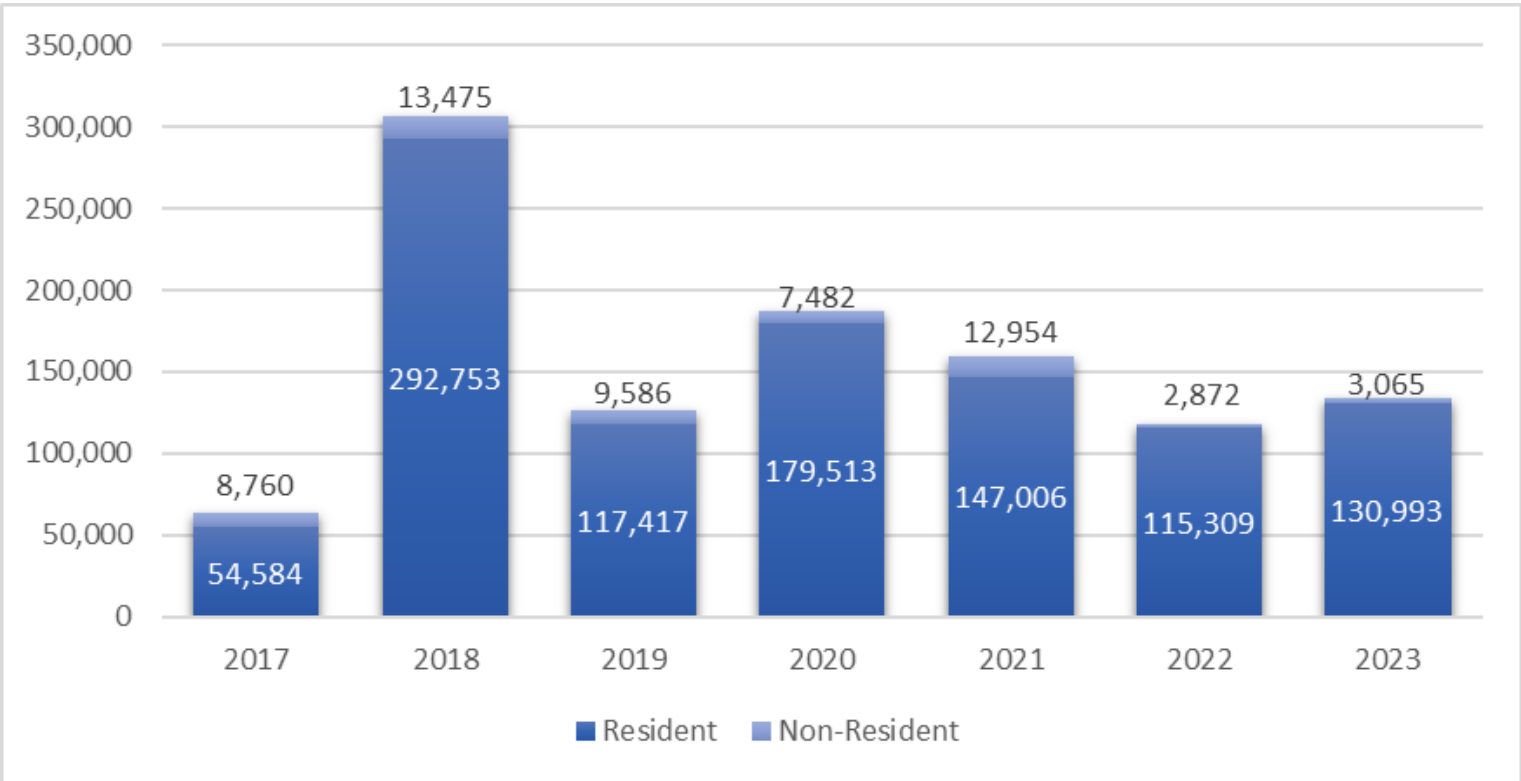

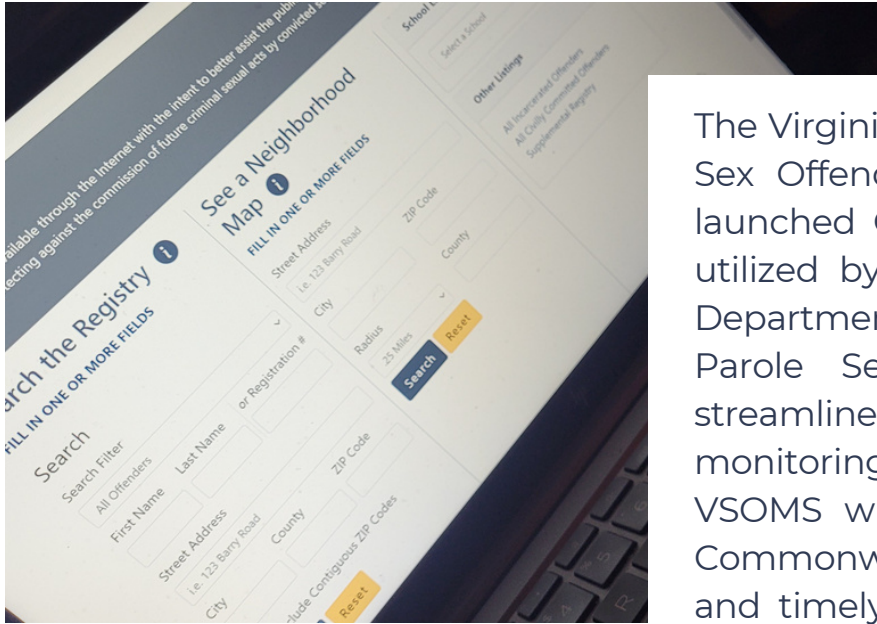
NUMBER OF TRANSACTIONS

VIRGINIA SEX OFFENDER MANAGEMENT SYSTEM (VSOMS)



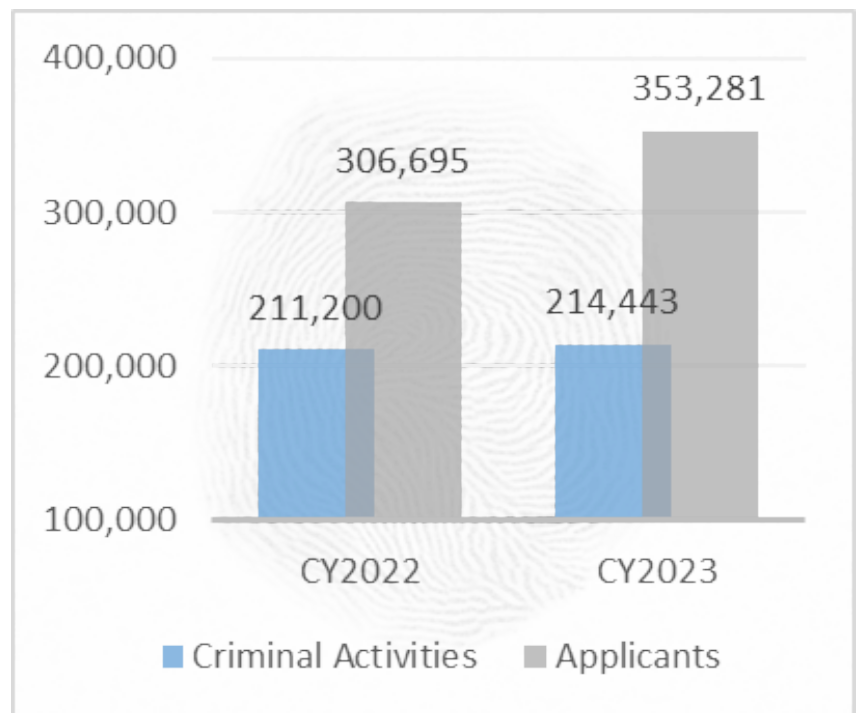
The Virginia State Police newly created Virginia Sex Offender Management System (VSOMS) launched October 30, 2023. This new system, utilized by the Virginia State Police and the Department of Corrections Probation and Parole Services, allows for a web-based, streamlined process of registering and monitoring offenders assigned to the registry. FACTS AND FIGURES

As we start a new year, the Biometric Records Section (BRS) is preparing to upgrade its Automated Fingerprint Identification System (AFIS) to the Multimodal Biometric Identification System (MBIS).

Before we embark on this new journey, let's take a moment to reflect on the past year. In 2023, BRS received a total of 567,724 fingerprint transactions. This is a 9.6% increase from 2022.



LIVESCAN INVENTORY PROJECT



The LiveScan Inventory is a project to confirm all hardware, networking information, points of contact, and active LiveScan terminals are in use. It has been over five years since the LiveScan team last did an inventory for all the Livescan equipment in the field.

To initiate the project, two surveys were sent to all agencies to collect current information about the setup at each location and point of contact information, respectively. This will provide the LiveScan team with the information required to provide a high level of service and optimize resource use.
